



特定金属くず買受業を営もうとする方は営業所ごとに、氏名、住所等を当該営業所の所在地を管轄する都道府県公安委員会に届出をしなければなりません。

届出をしないで特定金属くず買受業を営んだ場合、6か月以下の拘禁刑若しくは100万円以下の罰金、又はこれが併科されます。

Individuals or entities intending to engage in the business of purchasing specified scrap metals must submit a notification of their name, address, etc. to the Prefectural Public Safety Commission that has jurisdiction over the location of their business, for their respective business locations.

Engaging in the business of purchasing specified scrap metals without submitting the required notification shall be subject to imprisonment for up to six months or a fine of up to 1,000,000 yen, or both.

拟从事特定金属废料收购业者，必须以营业所为单位向管辖营业所所在地的都道府县公安委员会报备姓名、地址等信息。未经报备从事特定金属废料收购业的，将处以六个月以下拘役或100万日元以下罚金，或两者并罚。

អ្នកដែលចង់ធ្វើអាជីវកម្មខាងទិញកម្ទេចលោហៈ ត្រូវតែចុះបញ្ជី ដាក់ស្នើរណ្តោះ អាសយដ្ឋាន និងព័ត៌មានផ្សេងទៀតទៅក្រុមប្រឹក្សាសន្តិសុខសាធារណៈខេត្តដែលមានសមត្ថកិច្ចតាមការិយាល័យនីមួយៗ។

ប្រសិនបើធ្វើអាជីវកម្មខាងទិញកម្ទេចលោហៈដាក់លាក់ដោយមិនមានការចុះបញ្ជី អ្នកធ្វើអាជីវកម្មនោះនឹងត្រូវដាក់គុកក្រោមរងខែ ឬបង់ប្រាក់ពិន័យក្រោមចំនួនរយេន ឬទាំងពីរ។

ผู้ที่ประสงค์จะประกอบธุรกิจรับซื้อเศษโลหะเฉพาะนี้ จะต้องยื่นแจ้งชื่อ ที่อยู่ ฯลฯ ของแต่ละสถานประกอบการต่อคณะกรรมการความปลอดภัยสาธารณะจังหวัดที่มีอำนาจกำกับดูแลสถานประกอบการดังกล่าว

หากประกอบธุรกิจรับซื้อเศษโลหะเฉพาะโดยไม่ยื่นแจ้ง จะมีโทษจำคุกไม่เกิน 6 เดือน หรือปรับไม่เกิน 1,000,000 เยน หรือทั้งจำทั้งปรับ

Cá nhân, tổ chức có dự định kinh doanh thu mua phế liệu kim loại đặc định phải nộp hồ sơ khai báo thông tin như họ tên, địa chỉ,... cho từng cơ sở kinh doanh, đến Ủy ban An ninh Cộng đồng tỉnh/thành phố quản lý địa bàn nơi đặt cơ sở kinh doanh đó.

Trường hợp kinh doanh thu mua phế liệu kim loại đặc định mà không thực hiện khai báo sẽ bị phạt giam tối đa 6 tháng hoặc phạt tiền tối đa 1.000.000 Yên, hoặc áp dụng đồng thời cả hai hình phạt.



金属盗対策法が施行される令和8年6月1日時点で、既に特定金属くず買受業を営んでいる方は、3か月の経過措置が設けられているため、令和8年8月31日までに届出をしていただく必要があります。

For those who are already engaged in the business of purchasing specified metal scrap as of June 1, 2026, the effective date of the Act on the Prevention of the Disposal of Stolen Specified Metals, a 3 month transitional period will be provided. Accordingly, a notification must be submitted by August 31, 2026.

对于在《关于防止特定金属制品盗窃销赃等法律》施行日2026年6月1日之前已从事特定金属废料收购业的经营者，设有三个月的过渡期，需在2026年8月31日前进行报备。

សម្រាប់អ្នកដែលកំពុងប្រតិបត្តិការជាអាជីវកម្មខាងទិញកម្ទេចលោហៈ ដាក់លាក់ហើយ នៅថ្ងៃទី១ខែឆ្នាំ២០២៦ ច្បាប់អំពីការទប់ស្កាត់ការលក់និងការទិញវត្ថុដែលជាលោហៈ ពាក់ព័ន្ធនឹងការលក់ដែលបានត្រូវលួចជាដើមត្រូវអនុវត្ត មានរយៈពេល៣ខែសម្រាប់វិធានការនៃអន្តរកាលបានត្រូវរៀបចំដូច្នោះ អ្នកត្រូវចុះបញ្ជីរហូតដល់ថ្ងៃទី៣១ខែឆ្នាំ២០២៦។

สำหรับผู้ที่ประกอบธุรกิจรับซื้อเศษโลหะเฉพาะอยู่แล้วในปัจจุบันนั้น ณ วันที่ 1 มิถุนายน ปีระวะที่ 8 (ค.ศ.2026) ซึ่งเป็นวันที่กฎหมายว่าด้วยการป้องกัน การจำหน่ายวัตถุโลหะเฉพาะที่ถูกโจรกรรมมีผลบังคับใช้ จะมีระยะเวลาดำเนินการเปลี่ยนผ่าน 3 เดือน ท่านจึงจำเป็นต้องยื่นแจ้งภายในวันที่ 31 สิงหาคม ปีระวะที่ 8 (ค.ศ.2026)

Tại thời điểm ngày 1 tháng 6 năm 2026, ngày luật “Luật phòng chống xử lý vật phẩm kim loại đặc định bị trộm cắp” được thi hành, do được áp dụng thời hạn chuyển tiếp 3 tháng nên những cá nhân và tổ chức đã đang kinh doanh thu mua phế liệu kim loại đặc định cần phải nộp hồ sơ khai báo trước ngày 31 tháng 8 năm 2026.



特定金属くずの買受けを行おうとするときは、

- 買受けの相手方*の本人確認を行う
 - 当該本人確認に係る事項等に関する記録を作成する
 - 当該記録を3年間保存する
- ことが義務となります。

本人確認の際、顔写真付き身分証明書等が必要になります。

例 運転免許証、マイナンバーカード、在留カード等

*買受けの相手方とは、売買契約等の名義となっている法人や自然人です。

When intending to purchase specified metal scrap, the following will be mandatory:

- Verify the identity of the counterparty
- Prepare records of matters related to such identity verification
- Retain those records for 3 years

A photo-bearing identity document will be required for identity verification.

Examples Driver's License, Individual Number Card (My Number Card), Residence Card, etc.

打算收购特定金属废料时，必须履行以下义务：

- 确认收购交易对象的身份
- 创建该身份确认事项等相关记录
- 保存该记录三年

确认身份时，需要附有面部照片的身份证件等。

例 驾驶证、个人编号卡、在留卡等

เมื่อจะรับซื้อเศษโลหะเฉพาะ ท่านมีหน้าที่ต้องทำดังต่อไปนี้

- ตรวจสอบและยืนยันตัวตนของผู้ที่นำเศษโลหะเฉพาะเข้ามาขาย
- จัดทำบันทึกข้อมูลเกี่ยวกับการยืนยันตัวตนดังกล่าว
- เก็บรักษานับที่ดังกล่าวไว้เป็นเวลา 3 ปี

ในการยืนยันตัวตน จำเป็นต้องใช้อเอกสาร เช่น บัตรประจำตัวที่มีรูปถ่าย

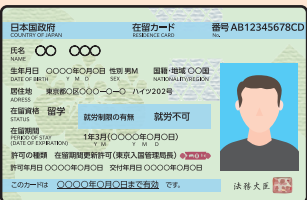
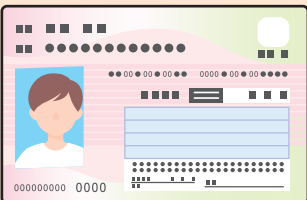
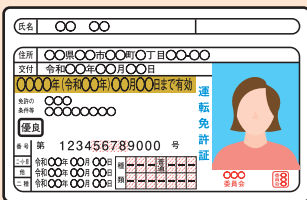
ตัวอย่าง ใบขับขี่, บัตรนายทะเบียน, บัตรผู้พำนักอาศัยสำหรับชาวต่างชาติ

Khi dự định thu mua phế liệu kim loại đặc định, bắt buộc phải thực hiện nghĩa vụ sau:

- Thực hiện xác minh danh tính của đối tác giao dịch
- Lập hồ sơ ghi chép thông tin liên quan đến việc xác minh danh tính nêu trên
- Lưu giữ các hồ sơ ghi chép này trong vòng 3 năm

Khi xác minh danh tính, phải sử dụng các giấy tờ tùy thân có ảnh.

Ví dụ Giấy phép lái xe, thẻ My Number, thẻ cư trú, v.v.





特定金属くずの買受けを行った場合、

- 当該買受けの相手方の氏名、当該買受けの内容等の記録
- 当該記録を3年間保存しなければなりません。

When specified metal scrap has been purchased, the following is required:

- Create records of the counterparty's name and details of the purchase
- Retain those records for 3 years

- บันทึกข้อมูลชื่อของผู้นำเข้ามายาข, รายละเอียดเกี่ยวกับการรับซื้อดังกล่าว
- เก็บรักษายบันทึกดังกล่าวไว้เป็นเวลา 3 ปี

Khi đã thực hiện thu mua phế liệu kim loại đặc định, bắt buộc phải thực hiện các nội dung sau:

- Ghi lại họ tên của đối tác giao dịch, nội dung giao dịch mua bán đó, v.v.
- Lưu giữ các hồ sơ ghi chép này trong vòng 3 năm



買受けの際に本人確認を拒否するなど怪しいと感じた場合は、#9110や110番通報での申告をお願いします。

If, at the time of purchase, you feel suspicious, such as when the counterparty refuses identity verification, please report the matter via the police reporting hotline number #9110 or by calling 110.

罰則 1年以下の拘禁刑又は50万円以下の罰金

Carrying certain cable cutters or bolt cutters concealed, without a work-related or other legitimate reason, is prohibited.

Penalties Imprisonment for up to one year or a fine of up to 500,000 yen.
