

# High School Supplemental Scholarship Fund (Repayment is unnecessary.)

Shotoku Kazei Shomeisho (income tax certificate) required to apply.

Households subject to tax exemption are eligible to apply for additional educational costs aside from tuition.

## Which household is eligible?

Households to which the 4 following descriptions are applicable are eligible to apply.

- ① Households who are subject to tax exemption OR receiving livelihood protection (employment assistance) .
- ② Parents or guardians residing in Tottori Prefecture.
- ③ Student attending school which is subject to High School Tuition Support Fund  
\* Except for students who attend special education high schools and living at a child support facility.

### ● Students attending a school in Tottori Prefecture

· The high school is going to announce to eligible households around July. Please submit an application form to the school before the deadline specified by the school.

### ● Students attending a school in another prefecture

· Please contact us for an application form. Please submit the application form to Scholarship Office by July 31, 2019.

● The annual amount of this scholarship will be paid between October and December.
